Application and Order for Reallocation or Transfer of Jackson Gulch Project Water Allotment

Application is respectfully made for reallocation or transfer (as indicated above) of Jackson Gulch Project water allotment, from the lands to which it has been attached by order of the Conservancy District, to certain parcels of said lands or to other certain tracts, all as specifically set forth on the reverse hereof, and in support of this application the undersigned state:

1. The undersigned constitute all of the owners and lienholders of all the tracts or parcels of real estate to which the allotment is now attached and to which the reallocation or transfer is sought.
2. The undersigned owners covenant and agree that they shall be bound by the agreements contained in the original petition and order covering the hereinafter-described allotment the same as if such were fully set forth herein and that they will put the waters herein allotted to beneficial use upon the lands respectively described.
3. The undersigned lienholders specifically consent to the granting of this petition and agree that their lien rights shall be subordinated to the assessment liens for the water allotments. If this be a transfer petition, the undersigned agree to the transfer of allotment made and release the water from their lien rights.
4. The undersigned understand that by its action in approving this petition, the board does not agree to install any additional distribution facilities but will continue to deliver the water to the headgate for which it was originally intended only and upon the order of only one person at the headgate. Responsibility for any change in delivery is upon the owners.
